TEEN ENROLLMENT FORM

Due to fluctuating gas costs, a onetime gas surcharge will be assessed at the time you pay the BTW fees using the schedule below:

- Gas ≥ \$3.50 Surcharge \$10
- Gas ≥ \$3.75 Surcharge \$15
- Gas ≥ \$4.00 Surcharge \$20
- Gas ≥ \$4.25 Surcharge \$25

Students 18 years of age and under are required to complete a state approved driver's education program prior to receiving a driver's license. Students 19 years of age and older may hold the learner's permit for 30 days in lieu of completing a driver training course.

FEES

Driver's Education Classroom (make check payable to **VWCC**)

1. **\$120.00 is due with the application**
2. The classroom fee is non-refundable after 4 classroom periods. Otherwise a full refund less a \$30.00 service charge will be made. A refund of any fees or tuition or any part of fees or tuition must be provided upon request unless the school is capable or willing to perform its part of the contract within a reasonable time period.
3. Each class will end promptly at 12:30pm. Please make arrangements to have your teenager picked up promptly.
4. Classroom meets Virginia State requirement of 36 *Fifty* minute periods.
5. Please make a photocopy of the student's Learner's Permit **and return it with the application**. We must keep a copy with our files. (Students may take classroom without having a Learner's Permit).
6. Any student missing a class period must make-up this time per DMV. The student will have the option of coming into a following class taught at no charge or time will be scheduled after the completion of the class at the rate of an adult lesson (\$40/hr). If more than one student needs to make-up time they will split the appropriate fees.

Driver's Education Behind the Wheel (make check payable to **Driving For All Ages, Inc.**)

1. \$275* (age 19 or under) **due first lesson**. Additional fees may be applied at the 1st lesson due to fluctuating gas costs.
2. Refunds will be calculated for the 1st 2 periods of BTW instruction based upon the hourly rate for a private lesson (\$40). After 1st 2 periods of BTW instruction only \$50 will be refunded if termination is necessary by either party. A refund of any fees or tuition or any part of fees or tuition must be provided upon request unless the school is capable or willing to perform its part of the contract within a reasonable time period.
3. **\$25 fee for cancellations NOT made within 24 hrs of lesson**
4. The student and/or parent will pay any damage caused by student to vehicle due to willful negligence (not an accident), up to \$500.
5. BTW meets Virginia State requirement of 7 *Fifty* minute periods of driving and 7 *Fifty* minute periods of observation. Situations may arise that the student will drive "one on one" with the instructor. All observation hours require at least one other student in the vehicle.
6. Any student not passing the Road Test will be held back for a minimum of 30 days to gain practice. A fee of \$40 will be assessed if a 2nd Road Test is given. The instruction provided does not guarantee that any student will pass the state license examination or that the student can secure a license or that the student will be guaranteed employment upon completion of any course instruction.
7. Students do **not** have to complete their 45 hours with parents before starting Behind the Wheel.

Driver Certificate will be withheld until

1. Books returned in good condition
2. All fees assessed are paid; Road Test will not be given until all Fees are paid in full; cash payment required if < 10 days between Road Test & final payment made.
3. Any returned checks have been paid including a \$30.00 service charge.

Additional Services We Provide

- Private BTW lessons for teenagers. These lessons will **NOT** be counted towards the Virginia State requirement of 7 *Fifty* minute periods of driving and 7 *Fifty* minute periods of observation. However private lessons can count towards the 45 hour required driving with parent/guardian. The private lesson is intended to give a student 1 on 1 instruction to gain confidence and/or cover topics that the parents are unable to cover. The charge for these lessons is \$40/hour.
- From time to time we have been asked to teach the classroom portion of Driver's Ed for a group of students (such as a sports team or religious group). We require a minimum of 10 paid students to provide this service. For more information please contact us at the number listed above.
- We offer private driving lessons to adults. These lessons can be "refresher" lessons for someone who hasn't driven in awhile, confidence building, and lessons for adults that have never driven before. The charge for these lessons is \$40/hour.
- In conjunction with Friendship Retirement Outpatient & Wellness Center we provide in car evaluations for adults who have been recommended to have an evaluation by the DMV, Doctor, or family member.
